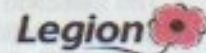




Memorandum of Understanding Between  
Athletics New Brunswick and  
The Royal Canadian Legion – NB Command  
Concerning the Legion Track & Field Program



This document has been completed to better outline the roles that both Athletics New Brunswick (ANB) and The Royal Canadian Legion, New Brunswick Command (Legion) play in support of the Legion Track & Field program in New Brunswick and to set clear expectations around those roles. This document can be reviewed or updated annually, and the parties agree to formally advise each other of any aspect that requires a change prior to April 1<sup>st</sup> of year.

#### **Team Selection, Standards & Declaration Forms**

- The standards will be calculated by the Legion, ANB will provide assistance with the standards when requested to do so.
- All required athlete forms will be developed by the Legion.
- ANB will provide assistance with translating the standards and forms from English to French.
- The standards and forms will be provided by the Legion to ANB by April 1<sup>st</sup> for publishing on their website.
- Team selection is the responsibility of the Legion, who may ask ANB to assist in the process.
- The athlete team fee will be set annually by the Legion. At the discretion of the Legion, this fee may be collected by ANB and then turned over in its entirety to the Legion.

#### **Selection Meet**

- The meet will be known as the "NB Legion Provincial Championships".
- The date and location of the meet will be set in the fall of each year for the next summer and be suitable to ANB and the Royal Canadian Legion representative.
- ANB is responsible for the organization of the competition including managing the meet, organizing the venue, obtaining officials and all other normal responsibilities of an ANB competition. It is understood that the host club is responsible for the organization of the competition.
- The event schedule for the competition is to be prepared by ANB staff and must be suitable to ANB and the Royal Canadian Legion representative.
- Meet registration fees will be collected by ANB and any resulting meet surplus will be shared equally amongst the host club, the Legion and ANB.

#### **Uniforms**

- The team uniform will be chosen by the Legion.
- ANB will provide competition singlets for the team and when possible will do so at cost.

#### **Coach Selection**

- Notice of opportunities for coach positions along with the criteria will be provided to the ANB membership by March 1<sup>st</sup> annually or soon thereafter and be open for a period of one month.

- The selection criteria will be prepared by ANB consistent with any expectations by the Legion program nationally.
- Any qualified ANB registered coach in good standing may apply for the positions.
- One position may be made available for a Developing coach who must have the NCCP Sport Coach (Level 1) certification in order to be selected.
- Following the application period ANB will compile the list of coaches who applied. This information will be provided to ANB's Provincial Selection Committee (PSC) consisting of three members. They will be assisted by one ANB staff member and the NB Legion Track & Field Committee Chair and one other Legion member selected by the Legion Chair in making the final selections. These selections will then be provided to the ANB board for formal approval.
- In order to avoid a possible or perceived conflict, those ANB PSC members or staff also applying for selection, must be excluded from the selection process and decision.
- If possible, PSC members and Legion members who belong to the same athletics club as a Legion coach applicant will not be part of the selection process.

### Cost Sharing

- The Legion will pay the following costs -

#### For the athletes -

- \* Team uniform;
- \* Bus or airline travel to Nationals; and
- \* Accommodations and meals at Nationals.

#### For the chaperones -

- \* Team uniform;
- \* Bus or airline travel to Nationals; and
- \* Accommodations and meals at Nationals.


#### For the coaches -

- \* Team uniforms.

- ANB will pay the following costs for the coaches upon receipt of an invoice from the Legion -

- \* Bus or airline travel to Nationals; and
- \* Accommodations and meals at Nationals.


